ASSOCIATESHIP FOR SACHIN TENDULKAR GYMKHANA AT KANDIVLI

Dear Permanent and Life Members,

This is to inform you that Mumbai Cricket Association (MCA) have allotted one Associateship of the MCA Sachin Tendulkar Gymkhana, Kandivli to the affiliated Member Clubs. Bombay Gymkhana being a Member of the MCA is eligible for Associateship for the Sachin Tendulkar Gymkhana, Kandivli. The applications from the affiliated Clubs are required to be submitted to MCA on or before Thursday, 30th April 2026. The admission fee required to be paid for the membership would be Rs.20,000/- plus GST.@ 18% i.e. Rs.23,600/-.

The matter was discussed at the Managing Committee meeting held on 30th March 2026, and it was decided that the Associateship for the Sachin Tendulkar Gymkhana at Kandivli would be auctioned to **Permanent /Life Members** of the Gymkhana at a floor price of Rs.5,00,000/- plus GST @ 18% i.e. Rs. 5,90,000/- and allotment would be made to the highest bidder.

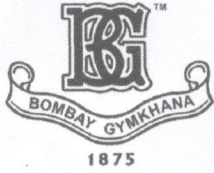
All **Permanent/Life Members** of Bombay Gymkhana who wish to apply for Associateship of Sachin Tendulkar Gymkhana, Kandivli are requested to kindly submit their bids in a sealed cover addressed to the Chief Operating Officer marked on the Envelope "**Bid for Associateship of the Sachin Tendulkar Gymkhana at Kandivli**" on or before 5:00 p.m. on 14th April 2026. The bids will be opened the same day in the Dining Hall at 5.15 pm, in the presence of the CEO, Bombay Gymkhana and COO, Bombay Gymkhana and the Members who have submitted their bids and any other Member who may wish to be present. Thereafter, the Gymkhana would announce the name of the Members who have submitted the highest bids for Associateship and he / she would be required to complete the application form immediately for submission to the Mumbai Cricket Association.

The bids should be accompanied with a cheque / DD for the full bid amount plus GST @18% as applicable, drawn in favour of "Bombay Gymkhana Ltd".

The encashment would only be done in respect of the Member who bids the highest and become eligible for Associateship.

Bids once submitted can be withdrawn till 3:00 pm on 14th April 2026. After that no request for withdrawal will be entertained.

It is further clarified that the Member and their family, as per the rules of the Sachin Tendulkar Gymkhana at Kandivli, would be able to utilize the facilities of the of the Sachin Tendulkar Gymkhana at Kandivli. The Member whose name is finally nominated by the Gymkhana for

Associateship shall not transfer/sell his/her membership & will be subject to rules & regulations as applicable to such membership.

Privileges of such a membership as given by MCA (Sachin Tendulkar Gymkhana at Kandivli) are listed below:

- a) Membership will be only till the life of the allotted member and returned to Bombay Gymkhana thereafter,
- b) Spouse member till the same date.
- c) Children can be dependent members – Boys till 21 years, Girls till 18 years of age.
- d) Dependent membership of children ceases beyond this age.
- e) No voting rights are offered to such member. (Associateship)
- f) This member is allowed to visit MCA- Sachin Tendulkar Gymkhana at Kandivali for 2 days on weekdays only.
- g) All charges are applicable as per club rules.

The Member submitting the bids are also requested to contact the Sachin Tendulkar Gymkhana to obtain full details in regard to his/herr entitlements and annual subscription.
